PRESIDENT'S OPENING REMARKS:

Wendy welcomed all the Delegates to the meeting and especially welcomed Senior Vice President, Colleen Moss, Junior Vice President, Carole Morgan and Benevolent Secretary Brenda Bowyer. Wendy said that she was looking forward to working with them this season.

MATTERS ARISING:

- D Area Selector: As a selector for D Area was not appointed at the AGM Sylvia Bloomfield has agreed to continue in this role. Maureen Norgate (Wanstead Central) will be shadowing her and assisting for the 2024 season.
- Competition portal. Update presented by Colleen Moss who had spoken with Dave Jarrold looking at the logistics of using the competition portal.

We have been trying for some time to look into what is involved with the running of a Competition Portal for the ladies to use, in conjunction with the one the men currently have in place. A few meetings/conversations have now taken place and this has raised some issues with the administration of the portal and the financial implications to the ECWBA. Using the figures from the 2024 season, it has been established that the cost to the ECWBA would have been £1070.90 for this year. (This does not include a software upgrade of £475). Whilst this may not seem a large sum, it is money that currently the ECWBA do not have to spare. Last year the ECWBA had a large deficit (Approximately £5,000) and unfortunately, larger ones are predicted for the future. If the ECWBA are to proceed with the Portal then the costs need to be found from somewhere. The cost of the portal will be covered by an increase in the competition entry fees. We will be going ahead with the Portal.

CORRESPONDENCE:

- Linda Mills encountered some difficulties last year when recording the points towards the County Badge. These were caused by substitutes not being indicated on the score cards. If a substitute is used in a competition SUB must be written by their name on the score card.
- Essex Ladies will have two entries at the National Championships in the Singles, 2 Wood Singles, Pairs, Triples and Fours. One entry in the Senior Fours, Junior Singles and Junior Pairs.

BOWLS ENGLAND REPORT:

1)This year the Bowls England Presidential Team have no JVP - it's intended that due to a reduced number of Celebration Games the JVP responsibilities will be divided between the President, SVP & Board Members although someone had approached Bowls England the morning prior to the AGM showing interest as yet we are still awaiting any updates on the situation

2) At the 2024 AGM it was agreed the 2025 Bowls England Affiliation Fee will increase aligned with inflation the inflation level will be taken from the Consumer Price Index based on inflation for September & County Associations will be advised of the exact increase in Mid-October

3) The following 19 Bowls England recommendations regarding 2025 competitions were voted on

 Elevate Blue Riband and Performance events at the National Finals – retain current formats in all rounds of blue riband events namely
 Singles 4 Bowls per player 21 shots
 Pairs 4 bowls per player 18 ends
 Triples 3 bowls per player 18 ends,
 retain current National Finals qualifier numbers in Blue Riband events
 adopt current approach to qualifier allocations by County per event
 play in qualifying rounds to be evenings & weekends – daytime by mutual agreement,
 qualifying for all four events to be managed by counties as current

2) To elevate top-level county competition consistent with world level for the Balcombe Trophy & Walker Cup

10 players per county Playing 4 disciplines Formats to mirror world level events

3) To amend players & formats in White Rose Trophy & Amy Rose Bowl

5 players per county playing 4 disciplines.

Maximum of two entries per county – 48 Nationally

Counties can merge for participation (not performance) reasons subject to agreement of Bowls England & Agreed plan to develop more junior players on county over course of 3 years.

No Senior Internationals permitted in White Rose Trophy & Amy Rose Bowl

4) To standardise the age in all junior events to under 24 on 1st April annually for both genders

Applies to White Rose Trophy, Amy Rose Bowl, Junior Singles & Junior pairs Qualifying for Junior Singles & Junior Pairs to be managed by Counties as current

5) To introduce an under 17 singles event for both genders

Managed as a National Competition by Bowls England

6) To create multi-county regional events

Provide a more intense experience for players and coaches replicating international competition.

Promote the sport of bowls and the essence of inter-county competition across the country Generate revenue and publicity for host clubs

Bowls England resources to support – commercial; broadcast;

Performance Team view all players at single venue

Understand Counties concerns re Logistics – Additional work undertaken 8 single green venues: geographically accessible; 8 venue winners progress to National finals

7) To retain Middleton Cup & Johns Trophy as a KO with Plate or Round Robin – it was voted on & agreed to accept the Round Robin format

8) To introduce a Mixed Over 60 Inter County event played as straight knockout

All players 60 & over on 1 April Annually 24 players per county (12 men & 12 women playing as 6 mixed rinks) All fixtures midweek/daytime on set dates Final Played during National Finals

10) To amend the Club Two fours to an open event

8 Players per club (playing 2 rinks)

Final stages played during National Finals

11) To restrict entry in the Champions of Champions to Club Champions ONLY

13) To increase the age limit for all senior events (excluding Senior Fours) to players aged over 60 on 1 April annually and permit daytime play in those events Applies to Senior Singles, Senior Pairs & Tony Alcock Trophy

14) To retain Senior Fours age limit in line with British Isles qualification requirements Currently over 55 on 1 April annually
Play to be evenings and weekends – daytime by mutual agreement
Qualifying rounds managed by counties as current

15) To Introduce Novice Pairs for new & less experienced players

One player who is not badged i.e. not played at National Finals One player no more than 3 years' playing experience (both could have less than 3 years' experience) All players under 17 eligible regardless of playing experience Entry policed at 'point of entry' Managed by Bowls England Further work by Implementation Group to clearly define entry criteria

16) To change eligibility to the Family Pairs to anyone who has NOT played International or County level (Balcomb and Walker) representative bowls in the last 5 years Further work by Implementation Group to clearly define entry criteria for players outside England

17) Competition Management

To further investigate how to consolidate the administration for the benefit of players and administrators as part of implementation plan, taking into account the array of systems already in place at County level

Single point of entry

Consistent dates nationwide for entry to enable national marketing campaign to drive entries

Online competitions management

18) Counties to continue to manage Championship events

Singles, pairs, triples, fours, U24 singles, U24 pairs, Senor Fours

19) Competition Management

To introduce set dates in the later rounds of the Top Club as a trial for 2025 as part of National Calendar

The above 17 propositions were voted on and passed

9) To re vamp the Top Club event

6 players per club (playing pairs and triples in sets format) Session 1 consists 2 teams of triples Session 2 consists 3 teams of pairs Separate events for each gender Final stages played during National Finals

12) To remove the 2 Bowl Singles Championship from the National Finals programme

Propositions 9 and 12 were voted on and rejected

Also, at the AGM the following 2 propositions were put forward by Devon & Cornwall:

Devon proposed adding the following paragraph to the qualifiers for the Nation Finals competition The counties with 2 entrants (A & B) shall be shown in the Championship draw to be in separate halves therefore removing the OPEN draw that is now in place

Cornwall proposed that the area final stage of the Tony Alcock Men's & Ladies top club & the Men's Club 2 fours to be played on a neutral green

Both Propositions were voted on and accepted
